GUIDE TO THE UNCLASSIFIED LAW LIBRARY COLLECTION

The Law Library has prepared this Guide to assist you in using the Law Library facilities and locating many of the basic legal research materials. For a detail description of the library services and collection, please refer to the Law Library portion of the Student Handbook. At any time, please feel free to ask for assistance at the Reference or Circulation Desks.

The first floor of the Law Library houses the Course Reserve, Florida, Federal, Reserve, Reference and Microforms Collections. The Course Reserve materials are located behind the Reference Desk. The Reserve Collection (in the Reading Room) and the Florida Collection (in the Microforms Room) are located on the south side of the building and are arranged in Library of Congress Classification number. The Reference Collection, located between the Reference and Circulation Desk, is also arranged by classification number. The Periodicals Collection is currently divided between the first floor north side and the second floor, here you will find the law reviews and journals, all shelved in alphabetical order by title with the law review indexes. The treatises collection (books) is also located in the second floor and arranged by Library of Congress classification number.

Material housed in the north side of the first floor is not classified. This guide will help in locating these collections.

Periodicals, reporters, indexes, federal material and some Florida materials do not have a classification number and only the location is shown in TOMCAT, our online library catalog. Please refer to the Location Guide that follows for specific floor/range location of this type of material. Ranges numbered 1xx are located in the first floor; and ranges with numbers 2xx are located in the second floor. Please refer to the library map for a layout of the collection.
