- Development of the general MBA with accelerated prerequisite courses was developed. The entire MBA core was expanded from eight courses to ten courses and the specialization courses were reduced from six to four courses. The result was that the average class size was increased from approximately 11 to 14 students to 16 to 20 students per class; where the numbers remain today.
- Implemented the A-term system for Management and Accounting majors at the Southwest Center under the direction of the Acting Vice-President of Academic Affairs. The Business Administration Department offered the following majors: Bachelor in Business Administration in Accounting Management (BBA.AC); Bachelor in Business Administration in Management (BBA.MGT); Bachelor of Arts in General Business (BA.GB); and Bachelor of Arts in Business Studies (BA.BS) at the Southwest Center (since closed) as well as the main campus at night. Since the Education Department no longer offers the entire undergraduate major at night, the Department of Business Administration currently offers one of the few evening undergraduate degree programs.

 opportunity for Business Internship was assured for each major. The BBA programs were
 reduced from 129 credits to 120 credits. Each major was redesigned to accommodate an
 internship opportunity. BUS 499 Business Internship can be incorporated into any major within
 the Department of Business Administration.

The program helped the MAC to grow significantly and to make the summer semester the largest semester (for student enrollments) for the MAC program.
