GUIDE TO THE UNCLASSIFIED LAW LIBRARY COLLECTION

The Law Library has prepared this Guide to assist you in using the Law Library facilities and locating many of the basic legal research materials. For a detailed description of the library services and collection, please refer to the Law Library portion of the Student Handbook. At any time, please feel free to ask for assistance at the Reference or Circulation Desks.

The first floor of the Law Library houses the Federal, Federal Tax, Florida, Reserve, Reference, Study Aids, and Microforms Collections. The Federal Tax, Florida, Reserve, Reference, Study Aids, and Microforms Collections are arranged by Library of Congress Classification number. The Reserve Collection, located behind the Reference and Circulation Desk, is also arranged by classification number. The Periodicals Collection is located on the second floor, where you will find the law reviews and journals. The treatises collection (books) is also located on the second floor. These collections are also arranged by Library of Congress classification number.

Most of the material housed in the north side of the first floor is not classified. This guide will help in locating these collections. Reporters, indexes, federal material and some Florida materials do not have a classification number and their location is shown as Unclassified Collection in WorldCat Local, our online library catalog. Please refer to the Location Guide that follows for specific floor/range location of this type of material. Ranges numbered 1xx are located in the first floor; and ranges with numbers 2xx are located in the second floor. Please refer to the library map for a layout of the collection.
