Miami School of Law, *summa cum laude*, and was inducted as a member of the Order of the Coif. While in law school, she served on the editorial board of the *University of Miami Law Review* and was awarded the Soia Mentschikoff Award for Excellence in Scholarly Writing for the best student note. She also earned eight book awards, including an award in Legal Research and Writing, and was a member of the University of Miami Moot Court Board.

She received the highest score on the Florida Bar Exam among test-takers within the Fourth DCA when she sat for the Florida Bar Exam, and she had the honor of speaking at the induction

ceremony before the Fourth DCA.

Professor Kenya Smith is an Associate Professor of Law; he teaches Business Associations, Federal Income Tax, Interviewing, Counseling, and Negotiations, and Contracts. His scholarly interests include formation and taxation of business associations, contracts, constitutional law and legislation. He is enthusiastic about education and scholarship, and loves to share that enthusiasm with his students.

He has served in various senior executive positions in the New Orleans city government, including Executive Counsel to the Mayor, Deputy Mayor for Intergovernmental Relations and Deputy Mayor for Community Development. Additionally, he worked closely with the BP Gulf Coast Recovery Leadership team in the wake of the MC-252 incident. He also practiced in a large, New Orleans-based private law firm.

Professor Smith maintains membership in several professional organizations, including the American Bar Association, the National Bar Association, the Federal Bar Association, and the Wisconsin and Louisiana State Bars. Professor Smith has also served as leader of local chapters of the American Red Cross and the National Urban League. He is also a member of the Honorable Order of Kentucky Colonels.

Professor Smith is an alumnus of Southern University at New Orleans where he received his B.A. *cum laude* in Political Science. He earned his J.D. from the University of Wisconsin Law School. He was previously a faculty member of the Arizona Summit Law School.

ACCOMMODATIONS

Students seeking in-class or examination accommodations under the *Americans with Disabilities Act* must make a formal request for such as soon as practicable. The law school will need adequate time to evaluate documentation and work out the specific accommodation. Requests for exam accommodations for the final examinations for the Fall 2016 semester **must be made no later than Friday, September 9, 2016**.

Students who seek accommodations or alterations in standard academic procedures because of a physical, learning, or mental disability must contact the Office of Student Affairs as soon as possible after enrollment at St. Thomas University School of Law. It is the responsibility of the student requesting such accommodation to do so in a timely fashion in accordance with the requirements as set forth in the *Disability Accommodations Guidelines Handbook*.

Students need not make their disabilities known, unless they want to request an accommodation. If seeking an accommodation, the student has the affirmative duty to inform the School of the disability and request the accommodation. Information about a student's disability is treated as confidential under applicable federal and state laws, and law school policies. This information is provided only to individuals who are privileged to receive such information on a need-to-know basis. Faculty members who are informed of a student's disability are advised this information is confidential.

Once a student's request has been granted, it is the responsibility of the student to request a modification of the accommodation should such modification be needed.
