#### INNOVATIONS IN TEACHING

I developed systems of graphic representations of complex contracts and secured transactions to assist students with visual understanding of highly conceptual commercial issues. Students endorsed my innovations in transactional methodology and teaching case law.

I created "Commercial Transactions Workbook: Problems and Solutions" that I provided to my students at no charge. Student performance on exams markedly improved.

At the invitations of AALS and the ABA, I presented my innovative teaching techniques to capacity audiences at the annual convention of The Association of American Law Schools c. 1993 and at the annual convention of the American Bar Association, c. 1992.

My students consistently awarded me highest scores for teaching: Contracts I (3 credits); Contracts II (3 credits); Torts I (3 credits); Secured Transactions (3 credits). Secured Transactions was an elective course in which only a handful of students had enrolled before my teaching Secured Transactions. After taking my Contracts and other classes, my Secured Transactions course became fully subscribed with more than 65 students in each class.
