# Appellate Litigation Clinic


The Appellate Litigation Clinic is a year-long clinic in which students have the unique opportunity to prepare and deliver oral arguments on real cases before the Third Court of Appeal.

Each student will work on two cases, beginning with the review of the trial court record for the cases, conducting legal research, drafting and filing briefs, preparing for oral argument, and arguing the case.



If you want to learn the ins and outs of litigating appeals in Miami, join the Appellate Litigation Clinic. Under the active supervision of an experienced appellate attorney, I received one-on-one professional training in the arts of oral and written advocacy.

My classmates and I were assigned a real case at the beginning of the year. We reviewed the record, identified and researched the issues to be raised on appeal, wrote the initial brief, then the reply brief and, if timing permits, we will



argue the case in front of Florida's Third District Court of Appeal.

The Appellate Litigation Clinic was the culmination of my legal education. I brought what I learned from my professors and the skills I practiced with Moot Court and Law Review to bear on a real-world problem. I cannot think of a better bridge between education and practice.

Additionally, I met esteemed bankruptcy professionals and law students from other schools. This externship not only enriched my legal education but also proved to be a valuable asset in securing an internship position with the United States Department of Justice, U.S. Trustee Program.

# Bankruptcy Externship

The Bankruptcy Externship is a single-semester externship that offers a comprehensive set of legal services focused on assisting and empowering low-income individuals in their interaction with the bankruptcy system.



# Civil Practice Externship

The Civil Practice Externship provides an opportunity for students to observe and participate in lawyering at government agencies and non-profit, public interest settings. **Typical** placements include legal aid services, city attorney or county attorney offices, state and local government agencies, school boards, and healthcare facilities.



I worked with the Department of Children and Families (DCF) Shelters Division through STU's Civil Practice Externship. I worked primarily on cases regarding the placement of children with foster families.

Doing the Civil Practice Externship has been one of the best experiences I have had while being a law student. I had the ability to attend hearings, meet judges and other attorneys, and learn first-hand how to argue motions. I believe that this experience will be invaluable for my career as an attorney.



One of the things I enjoyed most about my time on the externship was the ability to work closely with the attorneys at DCF. I had the ability to draft motions and assist in trial preparations. These have helped me gain skills that go beyond what I am learning in the classroom, and I am grateful for the opportunity that I have been given.

# Criminal Practice Externship

The Criminal Practice Externship provides an intense exposure to actual trial experience and motion practice. Students assigned to the State Attorney's Office experience representing the State of Florida in criminal prosecutions.

Students assigned to the Public Defender's office represent indigent adults and minors charged with felonies and misdemeanor crimes. Issues often involve the legality of searches and seizures, identification procedures, or confessions, along with defenses of insufficient evidence, mistaken identity, alibi, entrapment, or self-defense.



# Elder Law Externship

Students in the Elder Law Externship represent elderly persons in their legal conflicts and end of life issues, learning the practice area and engaging in its distinct ethical and practical challenges.

Students work on income maintenance, health care, long-term care, competency, guardianship, and probate.



I had the invaluable opportunity to intern with the Miami-Dade Probate Court. The judge I interned with and her amazing team fostered an environment where I was able to learn and grow tremendously in my research, writing, and problem-solving skills. I gained knowledge regarding court room etiquette as I was able to attend various Probate, Guardianship and Mental Health Proceedings.

This opportunity allowed me to have exposure to more challenging Probate



and Homestead issues. I gained helpful insight regarding how the Florida Probate Code was applied in these proceedings and attained knowledge while observing the resolutions of trust related litigation. This program was such a rewarding and impactful part of my law school experience.

# Florida Supreme Court Internship

During the Florida Supreme Court Internship, the intern functions as a law clerk to an individual Justice or as a central staff law clerk working for all of the Justices. Duties include reviewing recommendations making on petitions for discretionary review, attorney disciplinary matters, and extraordinary writ petitions, and conducting legal research preparing memoranda for cases pending before the Court.



# Immigration Clinic

This is a year-long clinic available to second and third-year law students designed to develop the technical legal expertise and the case development and trial skills needed to provide impactful representation to immigrants.

Students represent asylum seekers, battered spouses and children, immigrant detainees, and non-citizens seeking relief from deportation in litigation before the Immigration Court.



The Immigration Clinic was one of the most exhilarating and worthwhile experiences in my law school career. I have garnered skills not only applicable to immigration law but to any practice.

I learned how to interview clients, gather evidence, prepare for trial, and argue before an Immigration Judge. I also learned to dissect statutes, how to file motions, applications for relief with the Executive Office for Immigration Review (EOIR), and to properly communicate with the court and the U.S. Department of Homeland (DHS).



To be part of this clinic is to see law in action. This was the closest to being a lawyer without being licensed. I had to find balance in my life, stick to deadlines, and put my personal feelings aside to be the best advocate. I entered the clinic not knowing what to expect, but I am leaving with an invaluable experience and unforgettable memories.

I am honored to have been an intern at the United States District Court for the Southern District of Florida with a Magistrate Judge. One of the primary aspects of my role involved conducting extensive legal research on cases before the court. I researched precedent cases, statutes, and legal doctrines to provide comprehensive analysis contributing to the judge's decision-making process. I drafted court orders involving multiple areas of the law and attended court in different proceedings states litigation, where I observed the day-today application of legal principles.

# Judicial Internship

This is a single-semester internship that provides experience within the judicial system. Students learn about judicial decision-making and use their analytical, research, and writing skills to draft opinions and memoranda for pending matters under the direct supervision of judges, their law clerks, and staff attorneys.



## Tax Clinic

This clinic gives students the opportunity to with underserved communities work and, supervision, under represent low-income clients involved in tax controversies before the IRS, the IRS Counsel, and the U.S. Tax Court.

Students perform outreach services by providing education on the rights and responsibilities of U.S. taxpayers to the community particularly those for whom English is a second language. Students are encouraged to attend Tax Court sessions.



The Tax Clinic has enriched my experience profoundly. Working alongside Professor and fellow clinicians has been an amazing experience. The clinic taught me that understanding the theoretical aspects of a notice of deficiency and the resolution process is one challenge, but effectively conveying this information to a non-U.S. citizen client in their native language, especially when they are in the process of regularizing their immigration status, presents an entirely different set of complexities.



The clinic reaffirmed my mission to advocate for the rights of every taxpayer in their dealings with the U.S. Internal Revenue Service (IRS). The profound satisfaction of achieving favorable settlements resonates deeply with me, rendering my participation in and selection of the tax clinic more personally significant than any academic accomplishment I could have envisioned.

Upon graduation, I will be pursuing a Master of Laws in Taxation (LL.M.), building on the solid foundation I received at STU Law.
