Christine has served as Official of the Roman Curia since 2011. She is in charge of *International Human Rights Law* and *International Humanitarian Law*. Before the institution of the Dicastery for Promoting Integral Human Development, she was Responsible for Research in International Human Rights Law and International Humanitarian Law at the Pontifical Council for Justice and Peace.

Since 2014, Christine participates in the *Steering Committee for Human Rights* of the Council of Europe (CDDH), as the Expert of the Holy See.

Her work mainly consists in research activities in these fields, lecturing in Courses and Conferences, as well as the participation in several delegations of the Holy See to Conferences of International Organizations.

Christine holds a Ph.D in International Law at the University of Paris *Panthéon-Assas* and the University of Rome *La Sapienza* (2009). Previous engagements include working in civil society organizations as well as research and teaching activity in the above-mentioned Universities. She is the author of several scientific publications on International Law issues (see below).
