VI. WORK IN PROGRESS OR IN PREPARATION

1. Book on *Mexico's Dynamics of Constitutional Change* which explores the structure and operation of the mechanism for constitutional amendment in Mexico as the exclusive vehicle to promote constitutional change. With more than 750 amendments since its enactment in 1917, the Mexican Constitution is the second most amended constitution in the world, only behind the constitution of the state of Alabama. According to leading scholars, this staggering number of amendments has created a practice of hyper-reformism or reform-mania that has undermined the identity and supremacy of the constitution within Mexico's political ethos. In the present, the constitution is much more seen as a political platform rather than the supreme law of the land. This book aims at making an introspection of the transformative practice that have led to this and elaborate on innovative strategies for the transformation of the theory and practice of constitutional change in Mexico from a comparative perspective by analyzing relevant doctrines such as the basic structure, the substitution and the unconstitutional constitutional amendments theories.

VIII. EXPERIENCE IN ENGAGING WITH POLICY PROCESSES

Pertaining to previous experience in engaging with policy processes, I can refer my participation as Member of the Committee of the United Nations High Commissioner for Human Rights for the Diagnosis of the Human Right's Situation in Mexico City, in 2007-2008. That was a pathbreaking effort to put in tune local policies on human rights with the principles and goals of the United Nations' agenda on human rights protection, that are still in force today. Other policy-oriented experience was my appointment as General Legal Counsel for Regulation and Consulting of the Institute for the Protection of Bank Deposits (IPAB) from 2017 through 2019. IPAB is a governmental independent agency created by Congress to insure banking deposits and provide stability to the Mexican financial system. For almost two years I engaged in a comprehensive process of reviewing an implementing internal policy at the Institute that would help any user of the nation's financial system to claim the protection of her savings in case of a bank's resolution in a swift and effective manner. Currently, I am totally focused on elaborating some strategies for the transformation of the mechanism for constitutional amendment in Mexico to prevent that political majorities circumvent or even trump constitutional principles and values -the constitution in sum, just because they hold control of the mechanism.
